My agency became the authority in the field of freelance work for experienced marcom professionals. With more than 130 exclusively represented freelancers working at more than 200 clients, including advertising agencies, public and semi-public authorities, NGOs and the corporate world. In 2008 Engels & Partners was sold to the Works Group.

Since then I have been passionately putting my experience and commitment to good use. I have been around the block a few times and I can help and inspire businesses to regain a sharp focus. I act as sparring partner and catalyst. Open, honest and dependable. Sometimes challenging and headstrong. But always constructive.
